ORDER OF REINSTATEMENT

On January 7, 2012, James F. Jackson, DDS (Respondent) petitioned the West Virginia Board of Dental Examiners (Board) to reinstate his controlled substances prescription writing privileges. In support of his petition, the Respondent represented the following:

1. That by Consent Decree and Order entered on January 7th, 2011, the Respondent was prohibited from prescribing, dispensing, or administering any scheduled controlled substances in the State of West Virginia.
2. That six (6) months from the date of the Consent Decree and Order, the Consent Decree and Order permitted the Respondent to petition the Board to allow him to exercise the privilege of prescribing controlled substances.

3. That the Respondent was ORDERED to enroll in and successfully complete a pharmacology course pre-approved by the Board. The course was to include an intensive course in the proper prescribing of controlled dangerous substances.

4. That the Respondent successfully completed the following twenty (20) hours of education in pharmacology:

- a. Prescribing Controlled Substances and the Law
- b. Record Keeping
- c. Pain Management
- d. Pharmacology / pharmacotherapy of Pain Management
- e. Physiology of Pain Management and Substance Abuse / Addiction

5. Further, the Respondent was ORDERED to enroll in and successfully completed a course in ethics pre-approved by the Board.

6. That the Respondent successfully completed the following five and a half (5.5) hours of Ethics:

- a. Introduction to Ethics, Professionalism, and Ethical Decision Making
- b. Ethical Dilemmas in Dentistry, First Series
- c. Ethical Dilemmas in Dentistry, Second Series
- d. Ethical Dilemmas in Dentistry, Third Series
- e. Ethical Dilemmas in Dentistry, Fourth Series

7. That the Respondent was ORDERED to successfully complete the Jurisprudence, Ethics and Risk Management (JERM) Examination administered by the North East Regional Board of Dental Examiners, Inc. and the Dental law examination given by the West Virginia Board of Dental Examiners.

8. That the Respondent successfully completed JERM on January 4, 2012, and the Dental Law Exam on January 7, 2012.

WHEREFORE, the Board having reviewed the Respondent's request for reinstatement of the privilege to prescribe controlled substances, it is hereby ORDERED as follows:

1. That the Respondent's Petition for reinstatement of his privilege to prescribe controlled substances is hereby GRANTED.

2. The Respondent shall maintain a separate log detailing all controlled substances prescribed, administered and dispensed. The Respondent shall list the name of the medication prescribed, administered or dispensed and the quantity of said medication, along with an explanation for the prescribing, administering or dispensing of the medication. A copy of this log shall be sent to the Board quarterly. This log shall be made available upon request by the Board or its designee at any time.

3. That all other provisions of the January 7, 2011 Consent Decree and Order shall remain in full force and effect.

4. That a true copy of this Order shall be forward to the Respondent as his last known address.
